GGBHA Preceptor Handbook MAY DO/MAY NOT DO List - There has been confusion amongst faculty as to whether a student can flush a saline lock independently. Saline is considered a medication. For now, it was decided that a nurse needs to be present for a student to flush a saline lock. This will again be discussed when the list is reviewed in fall. HSHS indicated that Externs who have demonstrated their ability can independently flush a saline lock.

AAH - Instructors (not students) will be able to administer oral narcotics but need to complete two courses (eLearnings) to do so.

MCE UPDATES – KAREN GANEY, AAH

- AAH will announce when Covid cards can be updated.
- For now, Hep B requirements will remain the same.
- **Educators are asked to remind their students to complete AAH's post evaluation survey, located in MCE (not the GGBHA survey).** Students receive an email three days prior to finishing their clinical.

COVID UPDATES

Bellin Health has only a few Covid cases. **Educators are reminded to make sure all their students complete the surveillance questions and enter the status of their vaccination.** This includes students who may be onsite for only one day. Regulatory agencies are stringently checking site Covid status and how it is being handled. Kelly appreciates everyone's response she has received in this regard.

HSHS Covid numbers are down significantly. More shadow type opportunities are being offered to students.

AAH

- OSHA has been making rounds, at some of their sites, to see how people are wearing their masks.
- There has been talk about easing some of the things they had to put on hold, such as observations by clinical students.
- Students were offered a limited opportunity to get fit test. AAH is questioning other opportunities and next steps to have students fit tested.

- Bellin College and NWTC fit test students and supply their masks. UWGB also does some student fit testing. AAH will discuss the possibility of opening the door to accepting the school's fit testing results, but students would need to be fit tested with Aurora's N95 mask.
- Covid patients will not be in one unit but will be located in different areas of the hospital.
- Weekly Covid surveillance tests do not need to be loaded into MCE, but schools will maintain a copy of the test results that can be shared with the sites, if requested. If a student tested Covid positive, then surveillance testing is not required for 90 days.
