STUDENT HOUSING – ANNIE SHORT, NEWAHEC

Annie asked members if it would be of value if NEWAHEC helped facilitate housing for clinical students pursuing a health care career. Members shared this would be valuable. Reasons included that some clinical students have declined coming to the area due to not finding affordable housing.

NEWAHEC would contact the health systems to recruit their professionals to house clinical students. Rental fee recommendations and agreement templates would be made available. Students would have access to see all the available rental options. Annie will continue to work on this initiative and hopes to have a process in place for September 2022 to begin recruiting professionals to open their homes to clinical students.
