FACULTY & STUDENT TB REQUIREMENTS – Sherri Hanrahan, Chris Vandenhouten, Brian Krogh

The CDC has changed their TB guidelines. The GGBHA's current TB policy is costly and time consuming for documentation. The GGBHA would like to align with the new requirements.

Chris Vandenhouten shared the survey results of the TB requirements for students and faculty that was recently sent to the GGBHA's clinical partners. The 20 respondents represented hospital (5), long term care / rehab (6), community health (7), other (2). Survey respondents were asked if they require annual TB testing (TST or IGRA) for their employees. 18 respondents replied 'Yes', while 2 said 'No'.

All respondents supported changing the TB screening policy for students and faculty to mirror that of the National TB Controllers Association and CDC recommendation (2019) – including symptom evaluation, and baseline TB screening (TBST-2 Step or IGRA) for those without documented prior TB disease or LTBI Followed by annual TB Risk Assessment (WI DHS TB Questionnaire Form F-02314) and Education.

Members approved moving forward with instituting these changes for students and faculty. There will still be a baseline screening. **For students and faculty going to a site outside the GGBHA, they will need to follow that site's TB policy.**

Next Steps: Chris, Sherri and Brian will draft guideline changes for approval at the next meeting.

FINAL REVIEW: MANDATORY MODULE UPDATES

The changes, as discussed at the 3/24/2024 meeting, were reviewed and accepted, with some minor tweaks. Following the 4/26/2024 meeting, the updated modules (HIPAA Privacy & Security, Infection Prevention, Professional Expectation in the Workplace, Safety in the Workplace) were added to the website.
