**EPIC TRAINING UPDATE – Chris Vandenhouten, UWGB**

There were no updates. Hoping to hear an update from Marquette at the ANEW meeting on October 2<sup>nd</sup>, on the product they are using to train their students.

**MCE UPDATES – ADVOCATE HEALTH**

Workday modules are available to anyone starting clinicals and will need to be completed. There is an offsite instructor orientation virtual link that can be shared with the offsite instructors with high-level information that the instructor may need to know to help support the student. Offsite instructors are required to collaborate with the student and their preceptors. A touch base will be needed for the beginning of clinicals, followed by a second touch base. The student will have a new document that will be ready in a few weeks that will attest to the document, the same as the other two documents that are already there. The instructor will watch the 10-minute video and sign saying they completed that. Advocate Health will monitor compliance and contact the schools if instructors are not completing. Instructors should not be added to MCE. The instructor's name should only be entered in the student's comments with their email information. The team will email the instructors with the expectation to watch the 10-minute recording and sign. More information will be sent to each school once the form for the students is ready.

**Discuss Career Exploration on the webpage – Brian, NWTC**

Each organization has its own process when it comes to shadowing. AHEC works with Inspire Sheboygan and helps facilitate career shadowing and career exploration.
