Governor's Task Force on the Healthcare Workforce Funding Opportunities

The task force aims to establish a regional healthcare alliance, attract and retain the healthcare workforce, expand career exploration for students, and continue high-quality clinical placements.

Feedback was sought for a grant proposal due in early March. Some members attended feedback sessions to provide input.

Christine Vandenhouten expressed concerns about managing the high volume of requests for youth apprentice and shadow experiences.

Laura Janssen mentioned the expansion of youth apprentice positions at their site and suggested group-focused shadowing sessions to manage the load.

Review: Mandatory Modules

The group reviewed mandatory modules on infection prevention, professional expectations, safety in the workplace, and TB education.

- **Cybersecurity:** Update stats and correct minor errors. Slides 2, 12, 13, and 34.
- **Infection Prevention:** Add notes on sharps container replacement and contact lens removal. Slides 2, 31, 40, 49, 52 and 81.
- **Professional Expectations:** Update references to former employees and adjust communication model examples. Slides 2, 8, 9, 15, 16, 22, 32, and 36.
- **Safety in the Workplace:** Split dense slides for readability and address emotional responses to safety-related content. Slides 2, 5, 6, 9, 25, 26, 53, 67, and 69.
- **TB Education:** Clarify fit testing requirements and update module count. Slide 12.
